

## Privacy Policy

At MedicCom the protection of your personal information is a priority for us. Our Privacy Policy (this document) outlines how we collect, use, store and most importantly, how we protect your information, so please take the time to read through and see what we are doing

MedicCom Pty Ltd (ABN 35 665 373 651) and its associated company Medic Cloud Pty Ltd (ABN 72 572 806 79) (collectively referred to as “MedicCom”, “Medic Cloud”, “we”, “our”, or “us”) are committed to protecting the privacy of your personal information. MedicCom is the telecommunications division of Medic Cloud, and both companies operate in close partnership to deliver integrated IT and communications services. As part of this relationship, certain personal information may be shared between MedicCom and Medic Cloud where necessary to deliver services, provide support, manage accounts, or comply with our legal and regulatory obligations. Both MedicCom and Medic Cloud act as data controllers (or “APP entities” under the Privacy Act 1988 (Cth)) in respect of any personal information they handle. Each entity is responsible for ensuring your information is managed in accordance with the Australian Privacy Principles and our joint Privacy Policy.

MedicCom complies with Australian government laws and obligations towards your privacy under the Telecommunications Act 1997 (Cth), Telecommunications (Interception and Access) Amendment (Data Retention) Act 2015, the Do Not Call Register Act 2006 (Cth), the Spam Act 2010 (Cth) and Privacy Act 1988 (Cth), and is bound by the Australian Privacy Principles (APPs) set out in the Privacy Act 1988 (Cth).

This policy explains how MedicCom collects, uses, shares, holds and retains your personal information as required in the normal course and scope of MedicCom's business or when required by law, whether you are a website visitor, employee, employment applicant, staff member of a MedicCom customer, or other private individual whose personal information is affected by MedicCom's services or activities (Data Subject or you).

Personal information is any information relating to an identified or identifiable natural person as defined by privacy laws in each country that we operate[1]).

Part 1 of this policy relates to MedicCom's customers and how we use the information that we collect from them, including any personal information and information transmitted via MedicCom's network in the course of providing services according to a MedicCom services agreement (Services). Part 2 relates specifically to recruitment and recruitment-related personal information. Part 3 applies to all visitors to the MedicCom websites, including, where applicable, customers and job applicants. This also includes the use of cookies.

Part 4 sets out information on how MedicCom protects personal information and on your rights as a data subject. Parts 4 and 5 will be relevant to all visitors to the MedicCom websites.

MedicCom may update this policy from time to time by posting the revised version on MedicCom's website.

### PART 1: CUSTOMERS

#### COLLECTION DATA COLLECTED FROM OUR CUSTOMERS

In order to provide our customers with Services, or to perform a function related to providing our customers with Services, MedicCom may need to collect and process certain data from our customers, which may include personal information relating to their staff or private individuals (Collection Data). This includes, in particular, the following types of data:

- customer contact details (such as the customer's name, address and contact phone number, in addition to the name, position and email address of members of staff who contact MedicCom on behalf of the customer);
- customer credit card details;
- credit information about the customer;
- each customer's password and username for accessing MedicCom's Services; and
- records of each customer's use of Services and that customer's communications with MedicCom.

As MedicCom may also collect personal information such as names and contact details from our customers' employees or authorised representatives, each customer must make sure that they have obtained the consent of such employees or authorised representatives to MedicCom collecting and using such personal information in accordance with this Privacy Policy.

The Data Controller with regards to the Collection Data and the related Services is MedicCom Pty Ltd or, if you are located in one of the countries with a local MedicCom subsidiary, this local subsidiary is the data controller.

Providing the Collection Data is voluntary and based on the free will of the individual or entity providing the Collection Data. However, if a customer does not provide MedicCom with the information MedicCom needs, MedicCom may not be able to provide that customer with the Services that customer wants or MedicCom may be restricted in the way that Services can be supplied.

Customers consent to MedicCom collecting the following information when using the MedicCom app as follows:

- Location data, including the precise or approximate location information from your mobile devices when the MedicCom app is running in the foreground (app open and on-screen) or background (app open but not on-screen), and transaction information relating to the use of the MedicCom

- app, including route details (such as date and time, start and finish locations, distance travelled);
- Usage data including access dates and times, app features, pages viewed, browser type, app crashes and other system activity; and
- Device data including hardware models, device IP addresses or other unique device identifiers, operating systems and versions, software, advertising identifiers, device motion data and mobile network data.

## TELECOMMUNICATIONS INFORMATION

Telecommunications Data has the meaning given in section 276(1) of the Telecommunications Act 1997 (Cth) (as amended or updated from time to time). Depending upon the Services Customers buy from us, we may and you consent to us collecting Telecommunications Data about you including:

- Transaction information relating to the use of the MedicCom app, including route details (such as date and time, start and finish locations, distance travelled), usage data on how customers interact with the MedicCom app, including access dates and times, app features or pages viewed, browser type, app crashes and other system activity;
- Device data on how customers interact with the MedicCom app, including hardware models, device IP address or other unique device identifiers, operating systems and versions, software, advertising identifiers, device motion data and mobile network data; and
- Technical information and general analytics such as web browser type and browsing preferences, Internet service provider, referring/exit pages, date/time stamps, IP address, time zone and geolocation data (if applicable), some of which is collected automatically, arising from your use of our websites or platforms, as well as information about your usage of our websites or platforms when browsing.

## HOW COLLECTION DATA IS COLLECTED

MedicCom usually collects Collection Data when our customers interact directly with MedicCom. For example, MedicCom collects information when our customers and members of staff provide information to MedicCom in person, by phone or email, or when customer details are entered on our websites or when you use the MedicCom app.

MedicCom may also collect Collection Data, including from:

- anyone authorised to act on a customer's behalf;
- MedicCom's employees, agents, contractors and suppliers;
- credit reporting bodies and credit providers;
- other telecommunication and information service providers; and
- public sources.

**HOW MEDICCOM USES COLLECTION DATA** MedicCom uses Collection Data to the extent necessary to provide customers with Services and related support. In doing so, MedicCom may use Collection Data for related purposes as required in the normal course and scope of MedicCom's business, such as:

- processing a customer's application;
- carrying out checks for credit-worthiness;
- provisioning or connecting each customer's Services;
- dealing with customer enquiries and providing customer with customer support;
- managing each customer's Services, including account management, billing, processing payments and collecting debts;
- investigating complaints and carrying out dispute resolution;
- administering MedicCom's agreement with each customer;
- product research and development, business planning and staff training;
- communicating with our customers about the Services; and
- informing our customer about special promotions that MedicCom offers and which MedicCom thinks may be of interest to customer, unless customer has requested MedicCom not to do so. MedicCom may tell customer about these services and offers via direct mail or electronic direct mail. You may opt-out of receiving direct marketing at any time by contacting MedicCom at [privacy@mediccom.com.au](mailto:privacy@mediccom.com.au) If MedicCom wants to inform its Customers about promotions and news of third parties, it will not do so without Customer's explicit prior consent.

We are also required by law to provide your name, address, telephone service number and other public number customer details to the manager of the Integrated Public Number Database (IPND) for the Approved Purposes.

Approved Purposes means:

- providing directory assistance services, operator services or operator assistance services;
- publishing and maintaining public number directories;
- providing location dependent carriage services;
- the operation of emergency call services or assisting emergency services under Part 8 of the Telecommunications (Consumer Protection and Service Standards) Act 1999 (Cth);
- assisting enforcement agencies or safeguarding national security under the Telecommunications Act, the Telecommunications (Interception and Access) Act 1979 (Cth) or any other applicable legal requirement;
- verifying the accuracy of information provided by the data provider and held in the Integrated Public Number Database (IPND) against the information the data provider holds;
- undertaking research of a kind specified in the Telecommunications IPND – Permitted Research Purposes Instrument 2007;
- assisting the ACMA, or its nominee, to verify the accuracy and completeness of information held in the IPND;
- meeting our obligations to any Government Agency (for example, the Australian Tax Office) or other law enforcement bodies; and
- any other purposes where permitted by the Telecommunications Act and any other applicable law

Unlisted service information is marked and controlled by the manager of the IPND to ensure that it is only used for the relevant Approved Purposes (unlisted numbers or suppressed

address listings recorded in the IPND are not available to the general public via public number directories or directory assistance services).

You must notify us of any change to your IPND data and you may request changes to the listing status of your Service by contacting us at [privacy@mediccom.com.au](mailto:privacy@mediccom.com.au).

Collecting and processing Collection Data for the purposes specified above is necessary to fulfil the Services towards the Customer[2], to protect MedicCom's protected interests specified above[3], and to supply promotional communication to which the Customer has consented[4].

#### **HOW MEDICCOM SHARES COLLECTION DATA**

MedicCom may need to share Collection Data within the MedicCom group of companies and with other organisations to the extent necessary for the supply of Services to our customers[5] or to protect MedicCom's interests specified below[6]. However, MedicCom will not share customer information with any third party for the purpose of marketing or for other purposes without the customer's consent, except to the extent necessary for providing the Services or to protect MedicCom's protected interests as required or permitted by law. In particular, MedicCom may disclose Collection Data to:

- MedicCom's suppliers, resellers and agents so MedicCom can supply the Services to the customer;
- MedicCom's out-sourced service providers who perform functions and Services on MedicCom's behalf, such as contact centre services, mailing functions or IT services;
- credit reporting bodies, credit providers or debt collection agencies if a customer does not meet its payment obligations;
- other telecommunications and information service providers for performing the Services;
- MedicCom's marketing channels with which MedicCom shares MedicCom's marketing activities;
- MedicCom's legal, accounting and financial advisers and within the MedicCom group of companies;
- customer's authorized representatives;
- any person, with customer's consent;
- government, law enforcement and regulatory bodies where this is required for MedicCom to comply with MedicCom's legal obligations; or
- a specified recipient to facilitate a purchase or potential purchase of the whole or any part of MedicCom's business.

For MedicCom Mobile customers on the Telstra Wholesale Mobile network, personal information relating to your use of the network will be collected and handled by Telstra in accordance with their Privacy Statement, which is available online here: [www.telstra.com.au/content/dam/tcom/personal/privacy/pdf/telstra-privacy-statement.pdf](http://www.telstra.com.au/content/dam/tcom/personal/privacy/pdf/telstra-privacy-statement.pdf)

When you apply for a service with MedicCom you may be subject to a credit check with a Credit Reporting Body (CRB).

We work with customer service partners that are located within and outside of Australia on credit-related matters. Where necessary, we give our partners secured access to the credit information they need to help manage your credit and your services.

The organizations that MedicCom may share Collection Data with may be located in countries outside the European Union such as the United States, Australia, New Zealand, Singapore, Hong Kong, Sri Lanka, the Philippines or member states of the European Union such as the United Kingdom. In case the recipient is located in a country outside the European Union that does not have an adequate level of data protection from the perspective of EU data protection laws, MedicCom will ensure that the recipient complies with a level of data protection that is considered to be adequate from the perspective of EU data protection laws. You can request insight in the respective documents at [privacy@mediccom.com.au](mailto:privacy@mediccom.com.au). You are aware that the recipient in third countries is still subject to different domestic laws and regulations regarding privacy and the protection of personal data which may vary from European standards.

**HOW MEDICCOM RETAINS COLLECTION DATA** MedicCom will store your personal information in Collection Data only as long as needed to satisfy the above purposes for which it was collected (normally after your Global Services Agreement expired) or as required or permitted by law.

#### **TRANSMISSION DATA**

Apart from collecting and processing the Collection Data, MedicCom will, while performing its Services to its customers, transmit data packages including personal data via its network (Transmission Data).

#### **THE TYPES OF TRANSMISSION DATA MEDICCOM COLLECTS**

MedicCom will deliver services and process all Transmission Data that is required to allow Customers to transmit information and data packages through MedicCom's network. This may be in particular:

- technical data such as IP addresses, routing information, beginning and end of every transmission, transmitted data amount, other data required for installing or maintaining a communication channel between sender and recipient; and
- content data, i.e. the content of the data packages sent through MedicCom's network.

**HOW MEDICCOM USES TRANSMISSION DATA** MedicCom processes Transmission Data to the extent necessary to provide the Services to the Customer, in particular to build up the connection between sender and recipient of data packages and transmit these data packages and (if applicable) to calculate fees for the use of the Services if these are connected to the amount of data transmitted.

MedicCom may also use certain technical Transmission Data in order to detect and resolve malfunctions in MedicCom's network and Services or in the case of factual indications for the unlawful use of the Services or the network to detect and prevent this unlawful use.

**HOW MEDICCOM SHARES TRANSMISSION DATA** MedicCom will share Transmission Data with other network operators and service providers to the extent necessary for fulfilling the data transmission requested by Customer and to cooperate with government, law enforcement and regulatory bodies where this is required for MedicCom to comply with MedicCom's legal obligations.

**HOW MEDICCOM RETAINS TRANSMISSION DATA** MedicCom will delete all Transmission Data directly after the requested network connection has been terminated except where it is necessary to retain certain Transmission Data for billing purposes (where fees are connected to the amount of data transmitted) or for detecting and resolving malfunctions of or security incidents relating to the Services and MedicCom's network or in the case of factual indications for the unlawful use of the Services or the network to detect and prevent this unlawful use. MedicCom may also be obliged to retain certain Transmission Data by domestic laws.

## **PART 2: RECRUITMENT**

### **THE TYPES OF PERSONAL INFORMATION MEDICCOM COLLECTS**

In order to process and assess your job application, MedicCom needs to collect and hold some personal information about you. The Data Controller in connection with this Part 2 is the relevant MedicCom entity you apply to. The types of information MedicCom may collect include:

- your contact details (such as your name, address and contact details);
- employment related information (such as your resume, employment details, qualifications, referees and other background checks, working rights checks and police clearances); and
- records of your communications with us.

If you provide us with personal information, this is based on your free decision and on your free will. However, if you don't provide us with the personal information MedicCom needs, MedicCom may not be able to assess or proceed with your job application.

MedicCom will only process sensitive personal data which you provide to us (that is personal data relating to an individual's racial or ethnic origin, political opinions, religious or other beliefs, political or trade union membership, philosophical beliefs, health, sexual orientation or criminal convictions).

### **HOW YOUR PERSONAL INFORMATION IS COLLECTED AND HELD**

MedicCom usually collects personal information about you when you interact directly with us. For example, MedicCom collects your personal details when you provide information to us in person, by phone or email, or when you enter your personal details on MedicCom's recruitment websites.

MedicCom may also collect personal information about you indirectly, including from your referees, recruitment agencies and third parties MedicCom engages to provide recruitment services on our behalf.

### **HOW MEDICCOM USES YOUR PERSONAL INFORMATION**

MedicCom uses your personal information to:

- assess and process your job application;
- make a decision about whether to employ you;
- make decisions regarding your employment with us if you become an employee;
- file in our records for future offers of employment (if you separately consent to this retention);
- maintain and update our records; and
- deal with your enquiries.

MedicCom will process your personal information for these purposes solely to the extent this is necessary for the application process and/or your subsequent employment with MedicCom.

### **HOW MEDICCOM SHARES YOUR PERSONAL INFORMATION**

MedicCom may need to share your personal information within the MedicCom group of companies and with:

- recruitment agencies and other third parties MedicCom engages to provide recruitment services on our behalf;
- your referees;
- third parties to conduct background and police checks;
- institutions who issued your qualifications;
- government, law enforcement and regulatory bodies where this is required for us to comply with our legal obligations or to protect our lawful interests; or
- a specified recipient to facilitate a purchase or potential purchase of our business.

MedicCom will share your personal information with the above third parties only to the extent this is required for the application process or your subsequent employment with MedicCom.

The organisations that MedicCom may share your information with may be located in countries outside the European Union such as the United States, Australia, New Zealand, Singapore, Hong Kong, Sri Lanka, the Philippines and member states of the European Union such as the United Kingdom. In case the

recipient is located in a country outside the European Union that does not have an adequate level of data protection from the perspective of EU data protection laws, MedicCom will ensure that the recipient complies with a level of data protection that is considered to be adequate from the perspective of EU data protection laws. You can request insight in the respective documents at [privacy@mediccom.com.au](mailto:privacy@mediccom.com.au). You are aware that the recipient in third countries is still subject to different domestic laws and regulations regarding privacy and the protection of personal data which may vary from European standards.

#### **HOW MEDICCOM RETAINS YOUR PERSONAL INFORMATION**

MedicCom will delete your personal information directly after the application process is finished unless you are employed afterwards at MedicCom or have consented to retention of your data for future employment offers.

**PART 3: VISITORS TO THE MEDICCOM WEBSITE** This section applies to all visitors to the website [www.mediccom.com.au](http://www.mediccom.com.au) or any other MedicCom website (Website). MedicCom Limited, the relevant MedicCom entity which operates the Website, is the relevant data controller under this Part 3 of the Privacy Policy. Where you are a customer, Part 1 will apply in addition to this Part 3. Where you apply for a job with MedicCom, Part 2 will apply in addition to this Part 3.

#### **THE TYPES OF PERSONAL INFORMATION MEDICCOM COLLECTS**

MedicCom may collect and process the following data about you:

- Information that you voluntarily provide to us via the Website: this may include your name, address, e-mail address and phone number and your financial and credit card information; and
- Information that MedicCom automatically collects about you:
  - technical information, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform; and
  - information about your visit, including the full Uniform Resource Locators (URL) clickstream to, through and from our site (including date and time); products you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page and any phone number used to call our customer service number.

#### **HOW YOUR PERSONAL INFORMATION IS COLLECTED AND HELD**

- Information that you provide to us: you may voluntarily provide us with information about you by filling in forms on the Website or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you register with the Website, subscribe to our Services and when you report a problem with the Website.
- Information that MedicCom automatically collects about you: With regard to each of your visits to the Website we may automatically collect information that is automatically transferred to us when you visit our Website as specified above.

#### **HOW MEDICCOM USES YOUR PERSONAL INFORMATION**

MedicCom will use this information:

- to enable you to use the Website and to provide our Services;
- to administer the Website and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
- to improve the Website to ensure that content is presented in the most effective manner for you and for your computer;
- as part of our efforts to keep the Website safe and secure; and
- to measure or understand the effectiveness of advertising we serve to you and others, and to deliver relevant advertising to you.

MedicCom will use the above information only to the extent required for MedicCom's protected interests[7], or where this is necessary to provide requested Services to you[8].

#### **HOW MEDICCOM SHARES YOUR PERSONAL INFORMATION**

We may share your personal information with suppliers and sub-contractors for the performance of our Services or where it is required to enable you to use our Website.

We may also share your pseudonymized technical information (e.g. IP addresses) with selected third parties including MedicCom group companies including:

- business channels for advertising purposes;
- advertisers and advertising networks that require the data to select and serve relevant adverts to you and others; and
- analytics and search engine providers that assist us in the improvement and optimisation of our site.

MedicCom will share your pseudonymized technical information with these third parties including its group companies only where such transfer is justified under MedicCom's protected marketing and improvement interests[9]. You may object to such transfer of data by email to [privacy@mediccom.com.au](mailto:privacy@mediccom.com.au) or by using a respective "do not track" tool in your web browser. For the above purposes, MedicCom will not share any directly identifying information (e.g. names, email addresses, etc.) without your

explicit prior consent except where this is necessary to provide any Services requested by you or to process any of your requests.

MedicCom may further disclose your personal information to third parties:

- in the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets;
- if any MedicCom group company or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets; or
- if we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use and other agreements. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

MedicCom may share your information with parties that may be located in countries outside the European Union such as the United States, Australia, New Zealand, Singapore, Hong Kong, Sri Lanka the Philippines as well as member states of the European Union such as the United Kingdom. In case the recipient is located in a country outside the European Union that does not have an adequate level of data protection from the perspective of EU data protection laws, MedicCom will ensure that the recipient complies with a level of data protection that is considered to be adequate from the perspective of EU data protection laws. You can request insight in the respective documents at [privacy@mediccom.com.au](mailto:privacy@mediccom.com.au). You are aware that the recipient in third countries is still subject to different domestic laws and regulations regarding privacy and the protection of personal data which may vary from European standards.

#### **HOW MEDICCOM STORES YOUR PERSONAL INFORMATION**

MedicCom retains your personal information only to the extent this is required for the purpose it has been collected for and as required or permitted by law.

#### **PART 4: COOKIES**

##### **COOKIES**

A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer if you give your respective consent upon the first visit to our Website. Cookies help MedicCom to collect information about visits to MedicCom's websites for marketing and statistical purposes to improve the way MedicCom interacts with customers and with its other Website users.

All accesses to pages on MedicCom's websites are "logged". The logged information contains such things as a list of the pages accessed and the sort of browser used. This information is used to check for attempts at "hacking", or other fraudulent activity, to indicate missing pages or other web server problems.

MedicCom also uses it to provide general statistics such as the number of people viewing particular parts of the site.

MedicCom uses cookies to authenticate customer access or to make sure customer is the same person over a given "session" time. MedicCom uses third party cookies (e.g. Google Analytics or Hubspot) to track how MedicCom's Website is used. We may provide a limited amount of your information to these third parties.

You can usually remove or block cookies by using the settings in your browser, but this may affect your ability to use MedicCom's websites.

Please note that third parties (including, for example, advertising networks and providers of external services like web traffic analysis services) may also use cookies, over which we have no control. These cookies are likely to be analytical/performance cookies or targeting cookies.

#### **PART 5: PROTECTION OF AND ACCESS TO PERSONAL INFORMATION HELD BY MEDICCOM**

##### **HOW MEDICCOM PROTECTS YOUR PERSONAL INFORMATION**

MedicCom treats your personal information as confidential. MedicCom stores your personal information electronically and/or in hard copy form. MedicCom takes a range of measures to protect the security of your personal information, including by storing electronic information in password-protected servers that are in restricted and monitored areas. MedicCom does not store credit card details on MedicCom's systems.

##### **HOW TO ACCESS AND CORRECT YOUR PERSONAL INFORMATION**

Your personal information can be accessed via your MedicCom account or by contacting MedicCom at [privacy@mediccom.com.au](mailto:privacy@mediccom.com.au)

MedicCom takes all reasonable steps to ensure that the personal information MedicCom holds about you is accurate, complete and up-to-date. You can access and correct most of your personal information (such as your contact details) using your MedicCom account. You can also contact MedicCom at [privacy@mediccom.com.au](mailto:privacy@mediccom.com.au) if you wish to access or correct personal information that MedicCom holds about you.

##### **YOUR RIGHTS**

You have the right to ask us not to process your personal data for marketing purposes.

You have the right to request information about the data we store[10], to demand the correction of incorrect data[11], and to demand its deletion[12] or the blocking or restriction of the processing of data[13]. You are also entitled to object to the processing of your data, provided the reason for the objection lies in your special situation and provided it is data we process to protect one of our protectable interests[14].
